Accepted full papers will be published in an edited book published by Springer, the International Journal of Business and Data Analytics, or the MTMI publication: Review of Business and Technology Research (RBTR). **It is assumed that the paper submitted is author's original work and accepted published papers in the RBTR shall be the copyright of MTMI. The paper must be submitted by the deadline to be included in the RBTR.** An extended version of selected papers presented at the conference will be considered for publication into one of MTMI journals.
